Officer Schiller,

The University of North Dakota Police Department is taking the following disciplinary action against you: a 40 hour suspension without pay (date to be determined by the supervisor) and a 6 month probation extension. This is based on the following circumstances resulting from the theft of a UND patrol vehicle on May 22, 2016:

 Your inability to adhere to policy and procedures as set forth by the department, as well as the University, namely UND Code of Conduct, UNDPD policy 340 entitled Standards of Conduct, UNDPD policy 700 entitled Department-owned and Personal Property, and UNDPD policy 706 entitled Vehicle Use.

As mentioned, you have the obligation as a law enforcement officer to ensure that the property entrusted to you by the citizens of North Dakota is well-maintained and secure at all times. Law Enforcement Officers are held to a higher standard by our community members and your violation of policy negatively reflects on fellow officers and the department. Any further violations will be grounds for discipline up to and including termination of employment.

This letter is to inform you that you are the subject of an administrative investigation for an alleged violation of misconduct.

The allegations of this investigation are: On Sunday, May 22, 2016, your UND patrol vehicle was stolen after being left unsecure in the parking lot of the Hamline Square Apartments on the campus of the University of North Dakota. The vehicle was subsequently stolen by an intoxicated female suspect and later found after a collision near Crookston, Minnesota. This constitutes violation of UND Police Department Policy 340, entitled "Standards of Conduct"; Policy 700, entitled "Department-owned and Personal Property"; Policy 706, entitled "Vehicle Use"; and associated University Policy.
