In Re: Murder of Caylee Anthony / Kidnapping of HaLeigh Cummings

HaLeigh Cummings' disappearance was a staged kidnapping executed by William Staubs (Cobra), Wayanne Kruger, and Rev. Richard Grund.

It required the complicity of HaLeigh Cummings' family members that included Crystal Sheffield, Marie Griffiths, Johnny Sheffield, and Ruby Kanger.

HaLeigh's kidnapping was staged by Staubs, Grund, and Kruger because the aforementioned were involved in the disappearance and death of Caylee Anthony.

Caylee died during a ritual of some kind, performed by Rev. Grund – either deliberately during a sacrifice; or accidentally during an exorcism. Her body was then placed in the trunk of Casey Anthony's car and abandoned.

**Two months after Caylee's remains were found in Orlando, HaLeigh was reported missing in Satsuma.**

One month after HaLeigh disappeared; Staubs interjected himself into the case and told the media (e.g. Jessica Clark – First Coast News) he had been sent into the HaLeigh case by “Reverend Richard Grund – the father of Jesse Grund (former fiancé of Casey Anthony).

On March 20, 2009, Staubs improperly revoked the bond of accused (now convicted) child molester Daniel Snodgrass while his cameraman filmed it. It was then published on the Web for the world to see.

- ⇒ This was done to create the illusion the monster that killed HaLeigh Cummings had been on the loose – but now had been captured. By default – this would make Daniel Snodgrass a suspect in the Caylee Anthony murder. At any rate – it would create reasonable doubt.

On March 22, 2009, Staubs and several others planted evidence at a rural location in San Mateo. They then ‘searched’ the area and ‘found’ evidence linked directly to HaLeigh (HaLeigh’s toys, nebulizer). They also found evidence linked to a man (e.g. sock). Staubs claimed he found a set of car keys at the search. He attempted to turn the keys into Capt. Dominic Piscitello at the Putnam County Sheriff’s Office but Piscitello declined to take them into evidence. Major Gary Bowling confirmed to me he was aware of this fake search.

- ⇒ This was done to create the illusion that HaLeigh had been at the rural location – in the trunk of a car. The PCSO did not cooperate with Staubs’ plan. The original plan was to broadcast the ‘news’ of the ‘search’ in the same way they did the Daniel Snodgrass bond revocation.

### **Rev. Richard Grund**

Rev. Grund contacted me in April of 2009 and encouraged me to communicate with William Staubs. I subsequently interviewed Grund.

Rev. Grund operates a business called the Supernatural Response Team. He purports to be a warrior that battles demons. He goes to locations that are possessed by demons and evil spiritual forces. He admits he is a former worshipper of Satan; he says he is now a Christian.

1. Rev. Grund told me he (and his wife) went to the home of George and Cindy Anthony in Orlando (at a time before Caylee disappeared). He told me that upon entering the Anthony home he leaned over to his wife and whispered (paraphrasing) ‘hold on – let’s see what they (the demons) do – they know I’m here’. He said the house was pure evil. He said items flew off a shelf by them self.

Grund has hereby established the home of Caylee Anthony is possessed by demonic forces. He is assessing the home.

2. Rev. Grund told me that Casey Anthony is possessed by a demon that was once worshipped as a god.

Grund has hereby established Casey Anthony is (actively in 2009) demonically possessed. This would have required an exorcism by the Supernatural Response Team.

3. Rev. Grund told me the Anthony family was plotting to frame his son Jesse Grund, him, and/or his family, for Caylee's murder.

Grund has hereby included himself as a target of the Anthony family plot to 'frame' somebody in the Grund family.

4. Rev. Grund told me the Anthony family hacked his computer and stole photographs from him.
5. Rev. Grund told me Casey Anthony attempted to obtain pubic hair from his son's shower to place on Caylee's body.

Grund is hereby asserting there are attempts being made to plant pubic hair on Caylee's body.

6. Rev. Grund (and Staubs) told me Casey Anthony attempted to cause Jesse Grund to go to Casey Anthony's car where it was out of gas (with Caylee's dead body in the trunk) in an effort to trick him into touching the trunk.

Grund is hereby asserting there are attempts being made to trick a Grund into touching the trunk of the car where Caylee's dead body had been known to be.

7. Rev. Grund (and Staubs) told me the Anthony family was paying a private detective to follow his son Jesse Grund to Atlanta where their objective was to gather some of Jesse's DNA by following him. They suspected the DNA was going to be planted.

Grund is hereby asserting there are attempts being made to improperly gather Grund DNA to be planted as evidence in the case.

8. Wayanne Kruger and Rev. Grund were placed on a 'no-entry' list for door security at the televised Caylee Anthony memorial on February 10, 2009 (same day HaLeigh Cummings was reported missing).
9. Wayanne Kruger told me she hoped Rev. Grund didn't "kill HaLeigh" in "one of his frickin' exorcisms".

I have provided probable cause for law enforcement to question Grund, Kruger, and Staubs.

However, I have much more evidence.

On June 9, 2014, I released an ebook entitled "In Re: Caylee Anthony (the shocking truth explained)" and detailed much of what I know.

Within a few days, Richard Grund filed a complaint to Amazon Kindle asserting I violated copyright by publishing his photo. However, I had Grund's permission to publish his photo, which is evidenced on page 108 of my book "In Re: HaLeigh Cummings (the shocking truth revealed)".

Grund is attempting to stop this information from coming out because it is all true.

HaLeigh Cummings' disappearance was a staged kidnapping executed by William Staubs (Cobra), Wayanne Kruger, and Rev. Richard Grund.

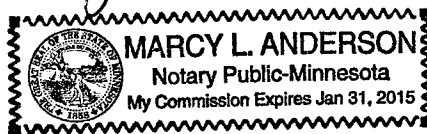
