This is a follow up to my letter dated June 18, 2014, regarding the staged kidnapping of HaLeigh Cummings as it relates to the homicide of Caylee Anthony.

Yesterday I listened to Rev. Richard Grund's interviews with law enforcement detectives dated September 5, 2008, which I found on You Tube.

I am inclined to contact you once again because I identified discrepancies between what Rev. Grund told police detectives, and what he told me. Further, I believe the truth about Caylee Anthony's death is known to Rev. Grund.

Rev. Grund told me during journalistic interviews, which I conducted with him in May of 2009, that he visited the Anthony home and found it was possessed by demonic forces.

However – he did not share that same information with the police investigators in the interviews I listened to.

This is a critical omission by Rev. Grund because he owns and operates a paranormal service called the Supernatural Response Team.

He told me:

- He leaned to his wife and told her to hang on – they'd see if the demons knew he was there - he said the demons knew he was there and became very angry
- Items flew from the shelf on their own
- Casey Anthony is possessed by a demon that was once worshipped on this earth as a god (Rev. Grund told me he once had an encounter with a fallen Watcher when he was into Satanic worship)

Rev. Grund did not tell the homicide investigators about any of this.

(Q) Why not?

What Rev. Grund neglected to tell law enforcement in September of 2008; coupled with his subsequent activities involving the mysterious disappearance of a second child; demands an investigation.

#### **SUPERNATURAL RESPONSE TEAM**

Rev. Grund owns and operates a paranormal service called the Supernatural Response Team that specializes in fighting demons and battling evils spirits. Grund was in the Anthony home. He is a paranormal specialist and was assessing the environment. He was watching items fly from the shelf with no human assistance. He believed Caylee's mother Casey was demonically possessed; and yet he neglected to tell that to homicide detectives?

(Q) Who invited Rev. Grund and his wife into the Anthony home? When did that occur? And who was present?

The National Enquirer reported in October of 2009 that records from the Orange County Prosecutor's Office contained files that revealed the Anthony's suspected Caylee Anthony may have died at Grund's hand during a ritual sacrifice.

(Q) Was Rev. Grund invited to the Anthony home by the Anthony family to perform the services of the Supernatural Response Team? Did those services somehow lead to the homicide of Caylee Anthony?

#### **GRUND CLAIMS HIS SON IS BEING FRAMED**

During Rev. Grund's September, 2008, interviews with the detectives he repeatedly states there is a plot by the Anthony family to implicate/frame his son Jesse Grund. During my May, 2009, interviews with Rev. Grund, he made the same claims.

Grund's consistent assertion is that DNA evidence is going to be planted, which links his son (or arguably, anybody the planter chooses to implicate with planted DNA evidence) to the crime.

As I will show you – Rev. Grund is obsessed with the idea/assertion that somebody is trying to frame his son by using DNA evidence to plant on the body, and continues to be obsessed with the idea, long after Caylee's body is found and in the custody of the Coroner's office.

I will show you a fact pattern that reveals Rev. Grund commissioned a mercenary type bounty hunter and sent him on a mission to Satsuma, Florida where another little girl mysteriously vanished, shortly after Caylee's remains were found. The bounty hunter executed a full scale public relations campaign to make it appear that a child raping murderer had been running wild in Florida.

### **GRUND'S INVOLVEMENT IN A SECOND MISSING CHILD CASE AND COMMISSIONING OF FELONIES**

On December 11, 2008, Caylee Anthony's body was found.

On February 10, 2009, HaLeigh Cummings was reported missing from Satsuma, Florida, which is 83 miles north of Orlando.

As you will see – Rev. Grund appears to behind it.

### **WILLIAM 'COBRA' STAUBS – THE FIRST COAST NEWS INTERVIEW**

*"...how did you all get through that Orlando thing..."*

On approximately March 17, 2009, William Staubs (a.k.a. Cobra), did an interview with Jessica Clark at First Coast News. This interview was live in person and recorded by Staubs. I have a copy of the interview.

Clark asked Staubs why he was involved in the case. Staubs said, "You know Richard Grund is the father of Jesse Grund – that's how I got this case – Richard Grund and I are friends – alright – and somebody called him and told him and said how did you all get through that Orlando thing down there are everything and he says I'll tell you what - you probably should get some lawyers up there you know for both sides of the family and everything – and you probably need to get some investigators up there..."

"I've been here six days now," Staubs said.

Throughout the entire interview, the only subject Staubs wanted to talk about was a man named Daniel Snodgrass. Snodgrass was a local man free on bond while awaiting trial facing charges of sexual battery on a child under 12. Snodgrass was Staubs' prime suspect.

While talking to Clark, Staubs brought up a current event regarding a journalist named Daniel Pearl who was kidnapped and beheaded by terrorists. Staubs was making behavioral comparisons between the terrorists and Daniel Snodgrass. "[Daniel Snodgrass'] modus operandi matches a lot of little shit that's going on," Staubs told Clark.

Staubs has now brought 'beheadings' into the matter while discussing Snodgrass with a news reporter.

During interviews with me, Staubs told me he found a shed in the woods that was wall to wall blood. He told me he believed Daniel Snodgrass might have butchered HaLeigh Cummings there. He also told me Snodgrass butchered little kids in the back of a limousine. He made these assertions despite the Sheriff's Office and FBI clearing Snodgrass. The Sheriff's Office checked the shed and said the blood on the walls was deer blood.

Regardless – Staubs continued to push his false narrative about Daniel Snodgrass. He wasn't interested in the truth – he was framing this innocent man in the public eye.

Staubs mailed me a pile of investigative documents that had been faxed to him by a legal entity in Broward County, Florida (available to law enforcement upon request) regarding Daniel Snodgrass.

Staubs told Clark, "He's got a (ankle) bracelet on and nobody knows for a fact where he was."

Valentine Bail Bonds, Jacksonville, is the agency that monitored Daniel Snodgrass' ankle bracelet. I interviewed David Valentine and he told me Snodgrass was nowhere near the address in question on the night in question. Mr. Valentine said he had serious questions about Staubs' motives, honesty, and integrity.

Staubs attempted to plant seeds of doubt to Clark about Snodgrass leaving the county, telling Clark that Snodgrass "breaks county line."

Staubs told Clark that Snodgrass was on his list since day one.

Because Staubs had been in Satsuma for only six days, and Snodgrass had been on his list since day one, that means Staubs' entire purpose since he arrived in Satsuma at the request of Rev. Grund, had been to do what he would do next, which was to revoke Snodgrass' bond while accompanied by a private tabloid journalist that would film the violent episode for publication on the Web.

## **BOND REVOCATION OF DANIEL SNODGRASS**

On March 20, 2009, Rev. Grund's operative, William Staubs, purporting to be acting under the authority of his bail bondsman license, traveled to the home of Daniel Snodgrass and revoked his bond. He called Snodgrass out of his house and then violently slammed the man onto the ground while he was handcuffed. Staubs had brought with him Art Harris, a disgraced tabloid journalist that once worked for CNN until he got fired. Harris filmed the event and then published it on the Web. The staged media event served to create the impression that 'Cobra' had captured the child molester that likely kidnapped and murdered HaLeigh Cummings.

Note: William Staubs was later arrested by the Putnam County Sheriff's Office and charged with felony false imprisonment for the Snodgrass incident.

## **PLANTED EVIDENCE / FAKE SEARCH**

On March 22, 2009, William Staubs and several others staged a search for HaLeigh Cummings at San Mateo, Florida.

At the fake search they found:

- HaLeigh's toys
- Suitcase
- Map
- Male sock
- Nebulizer fluid (HaLeigh uses a nebulizer)
- Car keys (belonging to Kristina Prevatt)
- Glove (with red stains)

Staubs attempted to turn the car keys into Capt. Dominic Piscitello at the Putnam County Sheriff's Office (PCSO) but Piscitello refused to take them. Capt. Piscitello's refusal to accept the 'evidence' shows local law enforcement did not trust the integrity of Staubs' so-called evidence.

I spoke with Major Gary Bowling at the PCSO and he told me the Sheriff's Office was aware that Staubs and the others had sprinkled evidence around at San Mateo.

## **WILLIAM 'COBRA' STAUBS – THE JACKSONVILLE TIMES-UNION INTERVIEW**

*"...helping Mr. Grund..."*

On June 9, 2009, William Staubs was interviewed by Dana Treen at the Jacksonville Times-Union. The interview was conducted by telephone. Staubs had already been

arrested and charged with felony false imprisonment of Daniel Snodgrass. He was not in Putnam County at the time of the interview.

“Pastor Grund down in Orlando – he’s a – I don’t know if you know him or not – Jesse Grund’s daddy – the one that they’re trying to accuse for murdering this girl now – well that’s another national case and that’s how I got started on this case here – brought into this case – helping Mr. Grund...” Staubs said.

“When I first went up there I went up there at the direction of Pastor Grund. You know a pastor asked me to go up there,” Staubs said.

“I was asked to do this case by a pastor and I’ll never do another one man – I pray please God don’t put it on my heart because I put \$40,000 of my own money into it...”

“Grund sent me here to look at everybody,” Staubs said.

“What was [Richard Grund’s] interest in all of this,” Dana Treen asked Staubs.

“There was a lady named Wayanne (Kruger). It goes back – this is what the deal was. Wayanne is a book-writer out of Arizona, California – someplace like that, she wrote a book. She married a dude and the dude ended up brutally raping her children for a long time or something and she actually got some kind of law passed wrote a book about it and now what she does whenever her health permits she travels around the country wherever somebody’s child’s come up missing and tries to offer counsel to the family she feels God put it on her heart. So when Pastor Grund was going through all this when Caylee Anthony – she showed up in town and introduced herself as – and Mr. Grund accepted her as a godly woman with good intents – and a friendship was mended off of that – and then she left from there and heard that this little HaLeigh was missing – similar sounding name – so she went up there – and then she went to go give condolences to both sides of the family – Misty (Croslin) she spent time with – Crystal Sheffield she spent time with – she actually called Mr. Grund and told Mr. Grund something was really wrong in this town with this investigation and these family members and everything else – both sides – but they’re dirt poor and they need an investigator. So Mr. Grund called me and said listen, I got a call from this lady Wayanne, I’ve known her for a long time, and I was wondering Cobra if you could spot a couple of days to go up to Satsuma meet up with her and see – just see what is going on – I said alright – so I did that – based on request from Pastor Grund who I already have a relationship with investigating folks that are trying to – in the Caylee Anthony case with Jesse Grund uh – I mean they’re trying – at one time – believe – we believe – that they were trying to plant DNA evidence showing that Jesse Grund the former boyfriend of Casey was – 18 months I believe – longest running boyfriend relationship they had actually he was going to end up marrying – and Pastor Grund if you want to know who the father was – not who the father, father like that but who, who was like daddy – that’s that man I mean he’ll start crying – that’s – I mean there’s a lot more to that case...”

## **TIMELINE**

**September 5, 2008** - Rev. Grund told homicide investigators during interviews there was an effort underway to frame his son Jesse Grund for the homicide of Caylee Anthony by planting DNA to implicate him

**October 14, 2008** - Casey Anthony was charged with murdering her daughter Caylee

**December 11, 2008** – Caylee Anthony’s body was found

**February 10, 2009** – HaLeigh Cummings, 5, is reported missing in Satsuma

- Memorialized in my book “In Re: HaLeigh Cummings (the shocking truth revealed)” on page 108, William Staubs told me he met Rev. Grund for the first time ever on **February 10, 2009**, at a memorial for Caylee Anthony at J. Blanchard Park in Orlando

**March 17, 2009** – William Staubs tells Jessica Clark at First Coast News he was sent to Satsuma, Florida by Rev. Richard Grund

**June 9, 2009** – William Staubs tells Dana Treen at the Jacksonville Times-Union he was sent into the case by Rev. Grund, with whom he already has a relationship because he is working for Rev. Grund investigating the people that are trying to frame Rev. Grund’s son

#### **SYNOPSIS OF TIMELINE (this is what you are expected to believe)**

Rev. Grund did not acquire the services of a private investigator when he first learned there was a plot to frame his son Jesse Grund with DNA evidence.

Between September of 2008 (police interviews) and December of 2008 (Caylee’s body found) Rev. Grund did not acquire a private investigator (and claims he did not know William Staubs).

On February 10, 2009, the same day HaLeigh Cummings mysteriously vanished, William Staubs and Rev. Grund met for the first time ever at a memorial for Caylee Anthony in an Orlando park. They talked – and Rev. Grund asked Staubs to be his pro bono private investigator to assist him in investigating an existing plot to frame his son Jesse for Caylee Anthony’s death.

However – Caylee Anthony’s body has already been found and been in law enforcement custody for **two months!** Nonetheless – Staubs is now going to work for Rev. Grund – for free - against the conspiracy to frame Jesse Grund using DNA evidence, which is to be planted on the body (a body which is now in the custody of the Coroner’s office).

One month later, Staubs will be in Satsuma, Florida, telling news reporters he is working for Rev. Grund on the case of the missing child HaLeigh Cummings – the child that

disappeared the exact same day that Rev. Grund and Staubs met and entered into their pro bono PI contract.

Once involved in the HaLeigh Cummings case – Staubs immediately launches a full scale media campaign against an accused child molester named Daniel Snodgrass.

## **THE SECRET HOUSE**

Staubs told me that he met Rev. Grund for the first time ever on February 10, 2009. He then told reporters he arrived in Satsuma on March 11, 2009, to search for HaLeigh Cummings at the request of Rev. Grund.

However – there is sinister evidence that Staubs (and a group of others) may have been living in the area HaLeigh Cummings disappeared from in a secret rented house located at 129 Oleander Drive, San Mateo, Florida.

I obtained a copy of a lease that shows that on April 30, 2009, Staubs switched the name on an existing lease for a house at 129 Oleander Drive, San Mateo, Florida, into the name “Donald Knop” by signing the name of “Donald Knop” who admittedly gave Staubs permission to do it.

The action obfuscated the name of the original lease-holder. It effectively re-set the lease to a six month lease from May, 2009 – Nov, 2009.

However – during my (recorded) interviews – the “little red house” came up many times - and the time frames referenced show people were coming and going from the house at 129 Oleander Drive in March and April of 2009.

If the original lease was a twelve month lease; that would mean it was originally leased in November of 2008 (shortly after Casey Anthony was indicted for murder).

If the house at 129 Oleander Drive was secretly leased in November of 2008, it is the KEY to the entire Caylee Anthony and HaLeigh Cummings cases.

## **SUMMARY**

In September of 2008, Rev. Richard Grund was interviewed by police detectives that were investigating a missing child case regarding Caylee Anthony (who was believed to be dead). Grund did not tell the investigators that he is a paranormal specialist that operates a business called the Supernatural Response Team. He did not tell the



investigators that he had been to the missing child's home and found it to be possessed by demons; as well as the child's mother, Casey Anthony, (the prime suspect) to be possessed by an ancient demon god.

In October of 2009 the National Enquirer reported the Orange County Prosecutor had files that showed the Anthony family suspected Rev. Grund may have killed Caylee Anthony in a ritual sacrifice.

The Anthony family's suspicions of Rev. Grund and a 'ritual sacrifice' should be of great concern to police investigators, because Rev. Grund never mentioned to police investigators during interviews, what he told me about the demonic home and demon possessed mother of the missing child.

Rev. Grund's failure to mention the demonic activity is incriminating, in light of the talk that Caylee might have died in a 'ritual sacrifice' or 'exorcism'.

Investigators might find themselves even more perplexed if the Anthony family never mentioned their 'ritual-sacrifice' suspicions to police; while simultaneously privately investigating their suspicions.

One might even wonder if there was something private going on between the Grund family and Anthony family that neither family was discussing with law enforcement.

In December of 2008, Caylee's body was found. In February of 2009, a little girl named HaLeigh Cummings was reported missing in Putnam County, Florida. In March of 2009, a bounty hunter named William Staubs, working for Rev. Grund, surfaces in Putnam County.

During an interview, Wayanne Kruger blurted out angrily to me that she hoped Rev. Grund didn't kill "HaLeigh" in one of his "frickin exorcisms".

Upon his arrival in Putnam County, Rev. Grund's operative, William Staubs, begins telling members of the media that an accused child molester from the area may have kidnapped and murdered HaLeigh Cummings. He makes sure to note that the accused child molester has been leaving the county despite wearing an ankle monitoring bracelet – claiming the ankle bracelet doesn't always work. He pushes this false narrative despite the accused child molester being cleared by the sheriff's office, ankle bracelet monitoring agency, and FBI.

Rev. Grund's operative, Staubs, plants evidence, sets scenarios, hires a tabloid journalist to publish false narratives about the HaLeigh Cummings case, and is ultimately arrested and charged with a felony by the PCSO.

The fact pattern shows Rev. Grund commissioned an agent (William Staubs) to create a false public perception through the media that a child raping murderer (Daniel Snodgrass) had been running wild in the State of Florida.

The objective was to obstruct justice, inflame the public's passions, create reasonable doubt, and influence any potential jury pool.

Rev. Richard Grund, William Staubs, Wayanne Kruger, George Anthony, Cindy Anthony, Casey Anthony, and Lee Anthony should be questioned regarding their involvement in the before mentioned matters.

Anybody involved with the house at 129 Oleander Drive, San Mateo, Florida, during the time in question should be questioned by law enforcement.

There is no statute of limitations on murder and all federal laws apply.
