On 07/16/2015 at approximately 1030 hours I, Officer Cory Amundson and FTO Ben Deckert spoke with a Timothy Charles Holmseth DOB 06/16/1968 in regards to harassment that is occurring over radionewz.net.

Holmseth believes that these harassing messages are being sent by a "Levi Page" under a false alias. Holmseth is concerned about the sexual comments being made about his two children and the threats made to him directly. This particular message was sent out 07/16/2015. Holmseth has had issues with "Page" in the past. "Page" is believed to be living somewhere in Tennessee and attending a university in the state. (the threats are attached to the call)

Holmseth also went on regarding federal cases he is involved in and was informed that they have to be handled on a federal level.

Myself and Officer Deckert informed Holmseth that he needs to contact the FBI on his behalf if he wishes to obtain either a search warrant on Levi Page and with any other questions regarding his federal cases.

Later in the day Marina Kathleen Holmseth DOB 3/23/1995 called into the Police Department. Marina was verifying that the information her father Timothy Holmseth had brought in earlier that day was all given to us. Marina was also wondering about obtaining a harassment order against "Page". I directed Marina to contact local her Law Enforcement Agency on obtaining a harassment order.

I contacted Austin Peay University and was able to obtain contact information for a Levi H Page DOB 07/19/1990.

I was able to contact and speak with Levi. Levi informed me he had nothing to do with writing the article about Holmseth. Levi said he has not had any contact with Holmseth since 2011.

I then spoke with Holmseth and notified him of the situation.
