**ORDER CONFIRMING EMANCIPATION OF
ALEC THOMAS HASH**

This matter having come before the Court upon the Verified Petition Confirming Emancipation filed by Petitioner through his attorney of record, Chris E. Ambrose, on February 7, 2014, and the Court having considered the petition and argument of counsel hereby finds that:

1.

Petitioner is a resident of Grady County, Georgia. Venue and jurisdiction are, therefore, proper in the Juvenile Court of Grady County, Georgia.

2.

Petitioner was born on January 13, 1997 and he is now seventeen (17) years of age.

3.

Petitioner was married to FRANCIA CHARLOTTE (CONTRERAS) HASH in Christian County, Missouri on May 9, 2013.

4.

Petitioner's father as well as his wife's mother both consented to the marriage in Missouri, and a copy of the marriage license was submitted to this Court as Exhibit "A" to

the Petition.

5.

Petitioner, having been validly married on May 9, 2013 was emancipated by operation of law on May 9, 2013. O.C.G.A. §15-11-201(b)(1). Therefore, Alec Thomas Hash is considered emancipated for the purposes of, but not limited to:

- (1) The right to enter into enforceable contracts, including apartment leases;
- (2) The right to sue or be sued in his own name;
- (3) The right to retain his own earnings;
- (4) The right to establish a separate domicile;
- (5) The right to act autonomously, and with the rights and responsibilities of an adult, in all business relationships, including, but not limited to, property transactions and obtaining accounts for utilities, except for those estate or property matters that the court determines may require a conservator or guardian ad litem;
- (6) The right to earn a living, subject only to the health and safety regulations designed to protect those under the age of eighteen (18) regardless of their legal status;
- (7) The right to authorize his own preventive health care, medical care, dental care and mental health care, without parental knowledge or liability;
- (8) The right to apply for a driver's license or other state licenses for which he might be eligible;
- (9) The right to register for school;
- (10) The right to apply for medical assistance programs and for other welfare assistance, if needed;
- (11) The right, if a parent, to make decisions and give authority in caring for

his own minor child; and

(12) The right to make a will.

6.

The parents and/or guardian of Alec Thomas Hash are not liable for any debts incurred by Alec Thomas Hash during the period of emancipation.


