Timothy Holmseth, complainant

On September 22, 2015, the Office of the Inspector General received correspondence from Timothy Holmseth. In his complaint, Mr. Holmseth stated:

- Attorney General Pam Bondi knows Lonzie Barton's relative, Haleigh Cummings, was trafficked for child porn through Florida DCF.
  - Ms. Bondi received 'Haleigh Cummings child porn' evidence and a Notice of Intent from Minnesota journalist Timothy Charles Holmseth on September 8, 2015 at 9:23 p.m.
  - Ms. Bondi received audio evidence of DCF Social Worker Bonnie Warner, discussing secret naked photographs of missing child, Haleigh Ann Marie Cummings, which Ms. Warner received on a CD during an after-hours meeting in a gas station parking lot.
  - On the audio, Ms. Warner is heard admitting she received the CD that contained the photographs and that she could not show it to her supervisor.
  - The secret photographs, which were given to Ms. Warner by an employee of a South Florida law firm, featured Haleigh Cummings' private parts in a sexually assaulted state, yet were never turned over to law enforcement.
  - That his reports/complaints regarding child pornography of a missing child are being deliberately ignored.
  - The State of Florida is concealing the true facts and circumstances surrounding the disappearance of Haleigh Cummings to avoid exposure and prosecution for violation of State and Federal laws.

- He possesses evidence that the State of Florida knows the positive welfare status and the physical location of Haleigh Cummings.

In order for the Office of the Inspector General to determine whether an investigation is warranted, the Northeast Region was asked to conduct an inquiry into the complainant's allegations. The following is the result of the inquiry:

The Department was not involved in the investigation of Haleigh Cumming's disappearance. The fact that she was missing was referenced in the 2009 investigations, but our initial investigations were in regards to a different child in the home.

The Department did have a Child Protective Investigator named Bonnie Warner during that time, but she resigned a number of years ago.

There is a Bonnie Warner currently associated with our Community Based Care agency in Circuit 7, but further review confirmed these two are not the same person.

The Northeast Region was not provided any evidence that Mr. Holmseth claims to possess. However, the Inspector General would forward any criminal allegations to the State Attorney. Mr. Holmseth states he has already done this.

DCF does not have the authority to investigate allegations against the Attorney General. Since Mr. Holmseth may be provided a copy of this inquiry, additional case information has been provided to the Office of the Inspector General that cannot be released to Mr. Holmseth.
